**Secretary**-The Secretary shall keep the minutes of all regular and special meetings of the Society and present them for approval of the Society at the next regular meeting. He or she shall also keep the minutes of the meetings of the Board of Directors. A summary of the minutes will be sent to the Editor for insertion in the following month's newsletter (not to include the actual treasury balance), and shall be posted to the Society's website.

**Treasurer**-The Treasurer shall keep the financial records of the Society, making regular reports to the Society which shall be incorporated into the minutes. He or she shall be empowered to collect all dues and receipts and to pay the bills and disburse the funds of the Society. He or she shall be the custodian of the Bylaws of the Society.

# Get the Creeps! - Andrea Smith

Halloween is an annual holiday celebrated each year on October 31. It originated with the ancient Celtic festival of Samhain, when people would light bonfires and wear costumes to ward off ghosts. In the eighth century, Pope Gregory III designated November 1 as a time to honor all saints and soon, All Saints Day incorporated some of the traditions of Samhain. The evening before was known as All Hallows Eve, and later Halloween. Over time, Halloween evolved into a day of activities like trick-or-treating, carving jack-o-lanterns, festive gatherings, donning costumes and eating sweet treats. Did you know that *One quarter of all the candy sold annually in the U.S. is purchased for Halloween?* What is your favorite candy?



Collecting spooky Halloween themed stamps has intrigued many a collector, and many countries have complied by issuing stamps with that theme. Even the U.S.P.S. has issued spooky stamps with enhancements.



The Legend of Sleepy Hollow was issued by U.S.P.S. in 1974 and much appreciated by collectors of all things Halloween.

On Sept 29, 2016 the U.S.P.S. issued the popular Halloween Pumpkin or "Jack

'O Lantern" stamps. These stamps really thrilled Halloween collectors all over the world.

Then, during the years 1997 to 2004, the United States Post Office made use of technology that allows a hidden image to be printed within the stamp design that can't be reproduced by using photographic techniques. They produced nearly 1.75 billion

postage stamps that contain a "hidden image". The First U.S. Stamp with a hidden image was the U.S. Air Force 50<sup>th</sup> Anniversary issue (Scott #3167). The hidden image was "USAF" with a star within a circle.

In 1997, the "Classic Movie Monsters" (Scott #3168-72) was the second series issued with Hidden Images. At that time, with the declining interest in philately, the



Postal Service was using every promotional effort to arouse interest in stamp collecting. It sent out 124,000 "Get the Creeps" kits to teachers nationwide in order to get youngsters interested in the hobby. The hidden images that relate to the stamps include masks on The Phantom of the Opera stamp, Dracula has a pair of bats, bolts of lightning on Frankenstein's monster, Egyptian Deities on the Mummy, and the Wolf man has howling wolves.

### How is this accomplished?

Scrambled Indicia® is Graphic Security Systems Corporation's patented pre-press process that scrambles, distorts, intertwines, overlaps or otherwise manipulates images making encoded information on them unreadable by the naked eye and can't be copied by current color copiers and digital scanners.

These covert designs are only visible when viewed through a special device called the "Stamp Decoder" which is an optical lens manufactured for reading hidden images and symbols on selected U.S. Stamp issues. On most of the stamp issues, the decoder should be placed horizontally (with the printed wording on the decoder facing up) to view the images while other stamps may require turning the decoder to a 15 degree angle to view them. The first U.S. Stamp decoder was issued in 1997, reissued in 1998, and finally in 2005. Unfortunately, these decoder devices can be difficult to locate.



Not to be outdone by the U.S., in 1997 Canada also issued a "Supernatural" series of stamps (Scott 1665-68).

The American Topical Association has numerous stamp checklists that relate to Halloween. Some popular ones include: Ghosts, Bats, Death, Dracula, Monsters, Vampires, Witches, and of course black cats. The Halloween checklist has 147 stamps that are worldwide stamps with the theme of Halloween. **BOO!**
